### A PROCLAMATION

By Her Excellency Leneen Forde, Governor in and over the State of Queensland and its Dependencies, in the Commonwealth of Australia.

WHEREAS Her Majesty has been graciously pleased to appoint me, Mary Marguerite Leneen Forde, to be Governor in and over Her Majesty's said State of Queensland and its Dependencies, in the Commonwealth of Australia: Now therefore I, the Governor aforesaid, do hereby notify, proclaim and make known that I have this day taken the prescribed Oaths before the Honourable John Murtagh Macrossan, the Chief Justice of the Supreme Court of the State, and that I have assumed the office of Governor of the said State accordingly.

Given under my Hand and Seal, at Parliament House, Brisbane, this twenty-ninth day of July, in the year of our Lord one thousand nine hundred and ninety-two and in the forty-first year of Her Majesty's reign.

### Greeting:

I. We do, by this Our Commission under Our Sign Manual and the Public Seal of the State of Queensland, appoint you, the said Mary Marguerite Leneen Forde to be, during Our pleasure, Our Governor in and over Our State of Queensland and its Dependencies, in the Commonwealth of Australia, with all the powers, rights, privileges and advantages to the said Office belonging or appertaining.

II. And We do hereby authorise, empower and command you to exercise and perform all and singular the powers and functions appertaining to that office.

Powers and Authorities.

III. And We do hereby appoint that so soon as you shall have taken the prescribed oaths and have entered upon the duties of your Office, this Our present Commission shall supersede the Commission under Our Sign Manual and Signet, bearing date the Third day of June 1985, appointing Our Trusty and Well-beloved The Honourable Sir Walter Benjamin Campbell.

Commission of 3 June 1985, superseded.

IV. And We do hereby command all and singular Our Officers, Ministers, and loving subjects in Our said State and its Dependencies, and all others whom it may concern, to take due notice hereof and to give their ready obedience accordingly.

Officers, etc. to obey the Governor.

Given at Our Court of Saint James's, this twenty-eighth day of April, 1992, in the Forty-first Year of Our Reign.
